Made this 14th day of August, 1990 to amend the Condominium Document of South Patrick Condominium Apartments, Inc. as recorded on August 31, 1972 in O.P. 1499, Pages 872-931, of the Public Records of Brevard County, Florida in accordance with Section 12, paragraph 12.3 (a) of the Declaration thereof. A proposed Board of Directors Resolution was duly accepted by seventy-five (75) percent of the voting shares of the condominium association to expressly change Exhibit B Section 1, paragraph 1.1 as amended by the Certificate of Amendment to the By-Laws recorded in O.P. 1499, Page 771. Section 1, paragraph 1.1 shall be amended to read as follows:

Annual Meetings shall be held on the common elements or at a place designated by the Board of Directors at 7 o'clock p.m. on the third Tuesday in January for the purpose of electing directors and transacting business; provided, if that day is a legal holiday, the meeting shall be held on the next day at the same hour and place.
