CERTIFICATE OF AMENDMENT
TO THE DECLARATION
of
SOUTH PATRICK CONDOMINIUM APARTMENTS
55 Sea Park Boulevard, Satellite Beach, Florida

Made this 29th day of September, 1972, to amend the Condominium Documents of South Patrick Condominium Apartments (recorded on August 31, 1972 as Clerk's No. 796546 in O.R. 1273 Pages 872-931 with the Brevard County Recorder) in accordance with Section 12.2(B) of the Declaration thereof. A Board of Directors Resolution proposed and duly adopted on September 20, 1972 was passed to expressly include maintenance of windows and sliding glass doors within the responsibility of the unit owner.

The Declaration is amended as follows: Section 3.4(a)(2) Vertical, add after the word walls:

" . . . walls, except such vertical boundaries shall extend to the outside exterior of perimeter walls at all points where window or sliding glass door openings exist in order to include all such windows and sliding glass doors as part of the unit."
